#### Who Is Required to Have This License?

LSA-R.S. 6:1421 defines a "Private education lender", as any person engaged in the business of securing, making, or extending a private education loan, or any holder of a private education loan. "Private education lender" shall not include any person who services a private education loan, to the extent such person does not also secure, make, extend, or own the loan. "Private education lender" shall not include any federally insured financial institution, its subsidiaries, and affiliates. The registration requirements shall not apply to a licensed lender pursuant to R.S. 9:3557 or any bank, savings bank, savings and loan association, or credit union operating pursuant to authority granted by the commissioner.

## **Activities Authorized Under This License**

This license authorizes the following activities...

 Private student loan lending – Acting as a lender by providing funds for a loan not guaranteed by the federal government to an individual for higher education purposes.

The Louisiana Office of Financial Institutions does issue paper licenses for this license type.

#### **Document Uploads Guidance**

Documents that must be uploaded to the *Document Uploads* section of the Company Form (MU1) in NMLS are indicated in the checklist below. When uploading documents:
