

## Company New Application Checklist Agency Requirements



## WISCONSIN EXEMPT COMPANY REGISTRATION

This document includes instructions for a depository institution to apply for a Registered Entity Exemption. If you need to complete a new application for a branch location (authorized delegates are not considered a branch in NMLS) or individual, refer to the appropriate new application checklists.

**Total Registration costs: \$1,100** including the NMLS processing fee. Fees collected through the NMLS ARE NOT REFUNDABLE.

Use the checklist below to complete the requirements for Wisconsin Department of Financial Institutions.

The checklist provides instructions and requirements for information to be entered in NMLS, the documents that must be uploaded into NMLS, as well as the documents that must be sent outside NMLS.

Agency specific requirements marked **Filed in NMLS** must be completed and/or uploaded in NMLS; this information will not be viewable to the agency until the application has been submitted through NMLS.
