

## **Connecticut Department of Banking (CT-DOB) Pre-licensure Education (PE) Notice**

---

### **Purpose**

The purpose of this notice is to inform NMLS approved course providers of the required topics to be covered in the 1 hour state specific pre-licensure education (PE) requirement which must be met as a condition for obtaining a mortgage loan originator (MLO) license with the Connecticut Department of Banking.

### **CT-DOB PE requirements are as follows:**

- 3 hours of Federal law;
- 3 hours of Ethics; include fraud, consumer protection and fair lending issues
- 2 hours of non-traditional mortgage lending;
- 12 hours of general electives;
- 1 hour of Connecticut state-specific defined electives

**Total PE: 21 Hours**

### **Required Learning Objective:**

- Identify practices that are fraudulent.
- Illustrate that MLOs signing documents on behalf of borrowers is fraud.
- Explain that MLOs requiring up-front cash payments from borrowers to take an application is fraud.
