The purpose of these release notes is to provide a summary of system enhancements included in NMLS Release 2015.3.

### General Enhancements

22714	Authorized Agents – Change Message when search results exceed allowed maximum	A change will be made to the message displayed when the composite search results for Authorized Agents exceed the allowed maximum. The new message will include an active link to the Authorized Agent Report search criteria for users with the Reports role.	State
21012	Authorized Agents – Multiple Agents at One Location	This enhancement will allow licensees to report and regulators to track multiple agents or terminals with the same EIN at the same physical address. A new Multiple Agent Location column will be added to the Regulator and Company versions of the Authorized Agent Roster.	State
21278	Authorized Agents – Pre-selection of Authorized Agent Roster Report	Users will be able to select a “View Agent Roster” button on the <i>Authorized Agents Home Page</i> , which will take the user to the <i>Reports</i> page with the Authorized Agents Roster Report pre-selected.	State
22523	Authorized Agents – Refactor Multiple Agent Location ID Handling in Upload File	The “Multiple Location Agent ID” field in the Authorized Agent Upload file will now be located in the sixth column between the “Address Street 2” and “City” fields.	State

21652	Authorized Agents – Relationship History Update Criteria	The <i>Authorized Agent Relationships</i> and <i>Authorized Agent Relationship History</i> pages will be updated to include information about when the agent record was last modified, as opposed to uploaded without any adjustments. There will also be an option added to the <i>Authorized Agent Relationship History</i> page to only view history records where the agent was modified.	State
21651	Authorized Agents – Roster Report (Company Version) Column Adjustment	The Authorized Agent Roster Report (Company) will be updated to reposition and rename the columns so that users can easily convert the Authorized Agent Roster Report into the UAAR Agent upload file.	State
21011	Authorized Agents – State Specific Review Item Triggers	The trigger rules for the current Authorized Agent File Uploaded review item will be updated so that the review item will only be generated when agents that are either located in the regulator’s state or conduct business in other states have been added, adjusted, or deleted. Users will also be able to search by reporting principal.	State
22030	Composite – Pending ACN indicator to link to the Pending ACN list	The “Has Pending Advance Change Notices” indicator on the Company and Branch Information pages in Composite View will now link to the <i>View Advance Change Notices</i> page.	State
21623	Regulator Work List – Derive and Filter Review Item Assignment Status	A new column and filter will be added to the <i>Agency Work List &amp; Assignment</i> page to allow users to filter work list items based on the status of review item assignments. Users will be able to filter and view work items that have i) all review items assigned or ii) some or no review items assigned to a user. This indicator will only be populated for work items generated or updated after the release. Work items without an indicator will be returned when both the yes and no checkboxes are not selected.
