GENERAL INFORMATION

Who Is Required to Have This License?

All sole proprietors, corporations, limited liability companies, partnerships, or other entities engaging in the business of money transmission or advertising, soliciting, or holding out as providing money transmission services. Delegates may be authorized by the holder of a money transmission license.

See Alaska Statutes (AS) Chapter 06.55 Alaska Uniform Money Services Act and regulations (3 AAC 13) under Alaska Administrative Code: Title 3, Chapter 13 for licensing authority.

Activities Authorized Under This License

This license authorizes the following activities:

- Issuing and/or selling drafts
- Selling prepaid access/stored value
- Electronic Money Transmitting
- Foreign currency dealing or exchanging
- Issuing money orders
- Issuing prepaid access/stored value
- Issuing traveler's checks
- Other-Money Services
- Selling money orders
- Selling traveler's checks
- Bill Paying

Pre-Requisites for License Applications

- Tangible Net Worth \$25,000
- Surety Bond \$25,000 plus \$5,000 for each location not to exceed \$150,000

Alaska Division of Banking & Securities does not issue paper licenses for this license type.

Document Uploads Guidance

Documents that must be uploaded to the *Document Uploads* section of the Company Form (MU1) in NMLS are indicated in the checklist below. When uploading documents:

- Follow the guidance in [Document Upload Descriptions and Examples](#).
- Only upload documents relevant to the company application.
- Only upload documents where there is a selectable document category. If inappropriate documents are uploaded that should not be, you will be contacted by your regulator and asked to remove them from NMLS.
- Do not upload the same company documents multiple times. Generally, unless the document is state-specific, if the document has already been uploaded for another state, a new upload is not required unless changes have been made.
- If a document previously uploaded has been revised, delete the old document and replace it with the new document (history of the old document will remain in NMLS).
- For state-specific documents (e.g., Surety Bonds), be sure to indicate the applicable state.
