## GENERAL INFORMATION

Per Business and Professions Code section 10100.2, a Department of Real Estate license or endorsement may only be surrendered upon acceptance by the commissioner when an investigation is pending or accusation has been filed to take formal discipline against the license or endorsement. If you request a surrender of your Mortgage Loan Originator (MLO) endorsement through NMLS, your endorsement will be placed into an “Approved-Inactive” status.

### Instruction

1. File the surrender request through NMLS.
2. There is no fee to surrender.
