## GENERAL INFORMATION

### Who is eligible to have this exemption?

This approved exemption is required for each location of an office to be maintained by the 501(c)(3) nonprofit organization other than the main office identified on the Company Form (MU1) filing.

### Pre-Requisites for License Applications

- A main office application (Company Form (MU1) filing) must have been submitted.

## Document Uploads

Documents that must be uploaded to the *Document Uploads* section of the Branch Form (MU3) in NMLS are indicated in the checklist below. When uploading documents:

- Follow the guidance in [Document Upload Description and Examples](#).
- Only upload documents relevant to the branch application.
- Only upload documents where there is a selectable document category. If inappropriate documents are uploaded that should not be, you will be contacted by your regulator and asked to remove them from NMLS.
- Do not upload the same company documents multiple times. Generally, unless the document is state-specific, if the document has already been uploaded for another state, a new upload is not required unless changes have been made.
- If a document previously uploaded has been revised, delete the old document and replace it with the new document (history of the old document will remain in NMLS).
- For state-specific documents (e.g., Surety Bonds), be sure to indicate the applicable state.

The Ohio Division of Financial Institutions does not limit the number of other trade names; however, the trade, fictitious or assumed name must be on file with the Ohio Secretary of State's Office.</p> <p><b>Note:</b> If the other trade name is used by ALL company locations, enter the other trade name in the <i>Other Trade Name</i> section of the Company (MU1) Form and Branch (MU3) Form. If the other trade name is only used by the branch, enter the other trade name in the <i>Other Trade Name</i> section of the Branch (MU3) Form.</p>	<b>NMLS</b>
<input type="checkbox"/>	<p><b>Branch Manager:</b> A Branch Manager must be designated for each licensed location. A Branch Manager is defined as an individual whose principal office is physically located in, who is in charge of, and who is responsible for the business operations of a branch office.</p>	<b>NMLS</b>
<input type="checkbox"/>	<p><b>Branch Manager (MU2) Attestation:</b> Complete the Individual Form (MU2) in NMLS. This form must be attested to by the applicable branch manager before it is able to be submitted along with the Branch Form (MU3).</p>	<b>NMLS</b>
